1. That I have full power and full authority to sign this liability waiver, and that I have understood the nature and type of the activity.
2. That I am in suitable physical and psychological condition to carry out the activity and that I do not suffer from any illness that could compromise my safety or that of other participants.
3. That I have not taken any drugs in the 48 hours prior to the activity and that I will not take any during the activity. That I am not under the influence of drugs and have not had too much to drink or eaten too much. That I am aware that, if I am not, the organiser and/or instructor may exclude me from participating in the activity and, in this case, I will not be entitled to any refund and/or compensation.
4. To participate in the activity and to carry out all actions for the performance of the same voluntarily and optionally.
5. To be aware of the foreseeable risks and be aware of the unforeseeable risks connected to the activity.
6. To be aware of the 'Official Pickleball Rulebook - 2025 Edition' (link: <https://usapickleball.org/what-is-pickleball/official-rules/>), that I have fully understood it and I accept everything contained therein, as well as any other rules that may be communicated in writing or verbally.
7. To behave in a non-violent manner and in any case in accordance with the rules of legality, public order and morality, towards the organiser, his/her legal representative and his/her employees and/or collaborators in any capacity, the instructors, the other participants, as well as third parties with whom I may come into contact during the course of the activity, the owners of the sites/places and equipment and, with the same behaviour, to use the facilities and equipment made available.
8. To assume, in a personal capacity, full criminal and civil liability, also towards the subjects and objects referred to in point 7, for all consequences deriving from participation in the activity and in particular, but not only, in the event of accidents, injuries, illness, damage.



9. That I am aware that no insurance cover is provided by the organiser, unless otherwise communicated in writing, and that I am responsible for any medical or insurance expenses.

10. That I am aware of the possible need for trips, inside and/or outside the structure, both organised by the organiser and independently. I accept all responsibilities and consequences of any nature for any damage that may occur during such movements and/or deriving from them, to myself, and/or to all the subjects referred to in point 7.

11. That I exempt and hold harmless the organiser, his/her legal representative, his/her employees and/or collaborators in any capacity, from any civil and criminal liability, including objective one, deriving from participation in the activity, from accidents and/or injuries suffered and/or as a consequence of injuries caused to myself or to third parties, as well as for illness (including death, or permanent or temporary disability) connected to the fulfilment of the initiative including accidents and injuries deriving from the actions of other participants.

12. To indemnify the organiser, his/her legal representative, his/her employees and/or collaborators in any capacity, from any claim of any nature made by third parties, also holding him/her harmless from any expenses, including legal costs.

That I waive any and all present and/or future claims for compensation and/or reimbursement against the organiser and his/her legal representative, his/her employees and/or collaborators in any capacity, exempting them from any liability and from all related actions, as well as from any type of judicial and/or arbitration proceedings relating to the risk of accidents, compensation for damages to myself, to third parties and/or to third party property, damage to equipment and the risk of loss of personal belongings due to theft or any other reason, and in any case from any loss/theft, except for the mandatory limits of the law.

14. To release and exempt the organiser and his/her legal representative, employees and collaborators in any capacity from any and all liability for any loss/theft, damage, theft and/or damage, expenses.
